i. Similar work shall mean "Civil Construction Works/Civil Maintenance Works and /or	
Civil Construction including Civil Maintenance Works."	
ii. The value of executed works shall be brought to current costing level by enhancing	
the actual value of work at simple rate of 7% per annum, calculated from the date of	
completion to last date of submission of bids.	
iii. Work executed as sub-contract or joint-venture will not merit for eligibility /evaluation.
