2. Eligibility Criteria for issue of Tender Documents:

Tender documents will be issued only to those who satisfy the following eligibility criteria:

a.	Should have satisfactorily completed the works as mentioned below during the last Seven (7) years ending previous day of last date of submission of bids. i. Certified copy of work orders and completion certificates issued by the authority concerned to establish work experience. ii. Completion certificates for works issued by private parties shall be supported by TDS (Tax Deduction at Source) certificate.

	ii. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of submission of bids.

Should have had average annual Financial turnover not less than 30% of the estimated cost (i.e. Rs. 26,68,380/-) of the work during the last three years ending 31st March of preceding year (i.e.2022)	Chartered Accountant certificate for the Annual financial turnover and balance sheet showing Profit & Loss.
c.	Should not have incurred any loss in more than two years during the last five years ending 31st March	
d.	Should have a solvency of 40% of the estimated cost of the work (i.e Rs. 35,57,840/-)	Current solvency certificate from any Scheduled Bank not more than 6 months old.
